- 3.3 The duties of the Information Officer include the following:
- 3.3.1 supervision.
 - 3.3.2 collecting data processing inventories.
 - 3.3.3 administration of data processing notifications.
 - 3.3.4 handling complaints.
 - 3.3.5 preparing annual reports.
 - 3.3.6 developing internal regulations and providing advice on technology and protection.
 - 3.3.7 ensuring that the rights and freedoms of the data subjects are unlikely to be adversely affected by the processing operations.
 - 3.3.8 raising awareness and provide training on data protection issues and encourage a culture of protecting personal data within his/her organizations.
 - 3.3.9 informing controllers of their obligations and making data subjects aware of their rights.
 - 3.3.10 ensuring that controllers and data subjects are informed of their rights and obligations pursuant to the local POPI Act and cross border considerations.
 - 3.3.11 making recommendations for the practical improvement of information and data protection to the FSP.
 - 3.3.12 advising the controller concerned on matters concerning the application of data protection provisions; and
 - 3.3.13 communicating with the Information Regulator and discussing any issues.

5 Who may request information in terms of the Act?

Any person, who requires information for the exercise or protection of any rights, may request information from a private body. Section 50 of the Act states that:

- 5.1 That record is required for the exercise or protection of any rights;
- 5.2 That person complies with the procedural requirements in this Act relating to a request for access to that record; and
- 5.3 Access to that record is not refused in terms of any ground for refusal contemplated in Chapter 4 of this Part.

6 The subjects on which the Company holds records and the categories of records are listed below. Please note that a requester is not automatically allowed access to these records and that access to them may be refused in accordance with Sections 62 to 69 of the Act.

7 Categories of records

7.1 Human Resources

Records found in this division contain information of employees that include the following:

- 7.1.1 any personal records provided to Paladin by the employee/personnel.
- 7.1.2 any records a third party has provided to Paladin about its personnel.
- 7.1.3 conditions of employment and other personnel-related contractual and quasi-legal records.
- 7.1.4 internal evaluation records.
- 7.1.5 other internal records and correspondence related to the particular employee.

7.2 Client related records

Clients include both juristic and natural entities that receive a service from Paladin. This information includes:

- 7.2.1 any records a client has provided to a third party acting on behalf of Paladin.
- 7.2.2 any records a Third Party has provided to Paladin; and
- 7.2.3 records generated by or within Paladin pertaining to the client, including transactional records.

7.3 Paladin Records

This category of records relates, but is not limited to, the following information:

- 7.3.1 Financial records
- 7.3.2 Operational records
- 7.3.3 Databases
- 7.3.4 Information Technology
- 7.3.5 Marketing records
- 7.3.6 Internal correspondence
- 7.3.7 Product records
- 7.3.8 Statutory records
- 7.3.9 Internal policies and procedures
- 7.3.10 Treasury related records
- 7.3.11 Securities and equities
- 7.3.12 Records held by officials of Centriq Insurance Company

7.4 Other Parties

Paladin may possess records pertaining to other parties, including without limitation, contractors, suppliers, subsidiary/holding/sister companies, joint venture companies, service providers. Alternatively, such other parties may possess records that can be said to belong to Paladin.

The following records fall under this category:

- 7.4.1 Personnel, client or Paladin records which are held by another party as opposed to being held by Paladin; and
- 7.4.2 Records held by Paladin pertaining to other parties, including without limitation financial records, correspondence, contractual records, records provided by the other party, and records third parties have provided about the contractors/suppliers.

8 Records available in terms of other legislation

The requestor may also request information that is available in terms of legislation, such as the following:

- 8.1.1 Basic Conditions of Employment Act (Act No 75 of 1997).
- 8.1.2 Compensation for Occupational Injuries and Diseases Act (Act No. 130 of 1993).
- 8.1.3 Employment Equity Act (Act No. 55 of 1998).
- 8.1.4 Labour Relations Act (Act No. 66 of 1995).
- 8.1.5 Occupational Health and Safety Act (Act No. 85 of 1993).
- 8.1.6 Promotion of Equality and Prevention of Unfair Discrimination Act (Act No. 4 of 2000).
- 8.1.7 Skills Development Act (Act No. 97 of 1998).
- 8.1.8 Skills Development Levies Act (Act No. 9 of 1999).
- 8.1.9 South African Qualifications Authority Act (58 of 1995).
- 8.1.10 Companies Act (Act No. 71 of 2008).
- 8.1.11 Short-Term Insurance Act (Act No. 53 of 1998).
- 8.1.12 Long-Term Insurance Act (Act No. 52 of 1998)
- 8.1.13 Financial Advisory and Intermediary Services Act (Act No. 37 of 2002)
- 8.1.14 Financial Intelligence Centre Act (Act No. 38 of 2001)
- 8.1.15 Financial Services Laws General Amendment Act (Act No. 45 of 2013)
- 8.1.16 Financial Markets Control Act (Act No. 55 of 1989); and
- 8.1.17 Financial Services Board Act (Act No. 97 of 1990).
- 8.1.18 Income Tax Act (Act No. 58 of 1962 as amended); and
- 8.1.19 VAT Act (89 of 1991)

Records relating to company reporting and Company related records as far as is allowed in terms of the above Acts may be requested.

Records relating to tax, employees and the company may be requested in terms of the above Acts.

The Information Officer will take into consideration section 8 of the manual to decide on whether access to any of the information stated above should be given to the requester.

9 Decision making process

- 9.1 In terms of Section 55, the information officer will take all reasonable steps to find a record that has been requested. If the record cannot be found or does not exist, the information officer must notify the requester by way of affidavit or affirmation, that it is not possible to give access to the record. This is deemed to be a refusal of the request. If, however, the record is later found, the requester must be given access if the requester would otherwise have been granted.
- 9.2 Section 56 provides that the information officer must within 30 days of receipt of a correctly completed request; notify the requester of the decision as to whether to grant the request. If the request is:
- 9.2.1 Granted: the notification must state the applicable access fee required to be paid, together with the procedure to be followed should the requester wish to apply to court against such fee, and the form in which access will be given.
- 9.2.2 Declined: the notification must include adequate reasons for the decision, together with the relevant provisions of the Act relied upon and provide the procedure to be followed should the requester wish to apply to court against the decision.
- 9.3 The information officer may extend the period of 30 days by a further period not exceeding 30 days if:
- 9.3.1 The requester is for a large number of records or requires a search through a large number of records.
- 9.3.2 Consultation between divisions of Paladin, or with another private body is required; or
- 9.3.3 The requester consents to the extension
- The requester must be notified within the initial 30-day period in writing of the extension, together with reasons therefore, and the procedure involved should the requestor wish to apply to court against the extension.
- The information officer's failure to respond to the requester within the 30-day period constitutes a deemed refusal of the request.
- 9.4 Section 59 provides that the information officer may sever a record and grant access only to that portion which the law does not prohibit access to.
- 9.5 If access is granted, access must be given in the form that is reasonably required by the requester, or if the requester has not identified a preference, in a form reasonably determined by the information officer.

10 Third Parties

If the request is for record pertaining to a third party, the information officer must take all reasonable steps to inform that third party of the request. This must be done within 21 days of receipt of the request. The manner in which this is done must in the fastest means reasonably possible, but if orally, the information officer must thereafter give the third party a written confirmation of the notification. The third party may within 21 days thereafter either make representations to Paladin as to why the request should be refused, alternatively grant written consent to the disclosure of the record. The third party must be advised of the decision taken by the information officer on whether to grant or decline the request, and must also be advised

of his/her/its right to appeal against the decision by way of application to court within 30 days after the notice.

11 Grounds for Refusal of a Request

Notwithstanding compliance with section 50, the request may be declined in accordance with one of the prescribed grounds in terms of the Act, namely:

- 11.1 Section 63 of the Act prohibits the unreasonable disclosure of the personal information of natural-person third parties to requestors. This includes the personal information of deceased persons. However, Section 63 (2) does provide exceptions to this.
- 11.2 Section 64 states that a request must be refused if it relates to records containing third party information pertaining to:
 - 11.2.1 Trade secrets.
 - 11.2.2 Financial, commercial, scientific or technical information where disclosure would be likely to cause harm to the commercial or financial interests of that third party; or
 - 11.2.3 Information, supplied in confidence by the third party, the disclosure of which could reasonably be expected to put the third party at a disadvantage in contractual or other negotiations, or prejudice the third party in commercial competition.

The information must, however, be released if it pertains to the results of products or environmental testing, the disclosure of which would reveal a serious public safety or environmental risk.
- 11.3 Section 65 prohibits disclosure of information if such disclosure would constitute a breach of any duty of confidentiality owed to a third party in terms of an agreement.
- 11.4 In terms of Section 66, Paladin must refuse a request for access to a record of the body if disclosure could reasonably be expected to:
 - 11.4.1 Endanger the life or physical safety of an individual.
 - 11.4.2 Prejudice or impair the security of a building, structure or system, including but not limited to a computer or communication system, means of transport or any other property.
 - 11.4.3 Paladin may also refuse a request for access to information that would prejudice methods, systems, plans or procedures for the protection of an individual in accordance with a witness protection scheme or safety of the public.
- 11.5 Section 67 mandates the refusal of a request if the record is privileged from production in legal proceedings, unless the person entitled to the privilege has waived the privilege.
- 11.6 Section 68 pertains to records containing information about Paladin itself and unlike the other provisions pertaining to declinature of a request, is not mandatory, but rather discretionary. Paladin may refuse access to a record if the record:
 - 11.6.1 Contains trade secrets of Paladin.

- 11.6.2 Contains financial, commercial, scientific or technical information, the disclosure of which would be likely to cause harm to the commercial or financial interests of Paladin.
- 11.6.3 Contains information which, if disclosed, could reasonably be expected to put Paladin at a disadvantage in contractual or other negotiations, or prejudice Paladin in commercial competition; or
- 11.6.4 Consists of a computer program owned by Paladin.
- 11.6.5 Notwithstanding the above, the information must be released if it pertains to the results of product or environmental testing, the disclosure of which would reveal a serious public safety or environmental risk.
- 11.7 Section 69 prohibits the disclosure of information about research where disclosure is likely to expose the third party, the person conducting the research on behalf of the third party, or the subject matter of the research to serious disadvantage. Disclosure is discretionary if such research pertains to Paladin itself.
- 11.8 Notwithstanding any of the above-mentioned provisions, section 70 provides that a record must be disclosed if its disclosure would:
 - 11.8.1 Reveal evidence of a substantial contravention of or failure to comply with the law, imminent and serious public safety or environmental risk; and
 - 11.8.2 If the public interest in the disclosure clearly outweighs the harm.

12 Rights of Appeal

- 12.1 A requestor that is dissatisfied with the information officer's refusal to grant access to any information may, within 30 days of notification of the decision, apply to court for relief. Likewise, a third party dissatisfied with the information officer's decision to grant a request may, within 30 days of notification of the decision, apply to court for relief.
- 12.2 It should be noted that notwithstanding any provision in this Act, the court may examine the record (s) in question. No record may be withheld from the court in any grounds. The court may not, however, disclose the contents of the record (s).
- 12.3 The court is empowered to grant any order that is just and equitable, including:
 - 12.3.1 Confirming, amending or setting aside the information officer's decision.
 - 12.3.2 Requiring the information officer to take any action, or refrain from taking any action as identified by the court within a specified period.
 - 12.3.3 Granting an interdict, interim or special relief, declaratory order or compensation; or an order as to costs.
